

# Dover Plains Library Kindle Paperwhite Loan Agreement



The Kindle Paperwhites may be borrowed by Dover Plains and Wingdale residents 18 years and older who have a current borrowing record of no fines, no overdues and no lost items.

Overdue fee for the e-Reader is \$1.00/day. A refundable \$25.00 cash or check deposit is required at check out. There are no renewals. The reader must be returned to the Dover Plains Library during operating hours. It **may not** be returned in the book drop. The fine for returning the e-Reader in the book drop or to any other library is \$50.00. Any damage incurred as the result of failed returns will be the responsibility of the borrower.

Failure to return the e-Reader within one week of due date will cause a block to the borrower's record prohibiting borrowing of any kind and a \$155 replacement fee will be charged.
